# Step 10: Sustainability

# Humanitarian projects – Project planning

Describe the community needs that your project will address.

- The official school curriculum only covers basic education. It does not integrate culture, or the environment and natural resources let alone the Zapotec language.
- The impacted community has a student population of 294 school-age students at the municipal level. The lack of resources and programs enabling young people to finish their basic education and continue their studies at the higher (or at least technical level) makes it very difficult for at least 20% to continue preparing.
- Another challenge needing to be addressed is that middle and upper level schooling is far from the municipality. Young people who strive to continue their studies to completion often fail to do so. Instead they seek work outside the community, as there is no local demand for their services, or remuneration for their work. This is considered a major factor leading to migration out of the community, resulting in a demographic composed of older adults, few young adults and very few children. The loss of its people also means the loss of its language, its culture, uses, customs and traditions.
- To address the above needs the community school bakery of Santa Catarina Lachatao aims to generate employment and income for the community. Above all, it is intended

to maintain and finance the Biocultural School of Santa Catarina Lachatao. The school will preserve the most important aspects of Zapotec culture, natural resources, and traditional knowledge associated with agrobiodiversity, production systems, natural resources, time, landscapes and history.

How did your project team identify these needs?

Participatory workshops:

Workshops were held in conjunction with the community, where the problem of migration of children and young people was specifically addressed from the limited educational offer as the main driver of this phenomenon.

How were members of the benefiting community involved in finding solutions?

During this stage, different approaches were addressed to mitigate the migration of families, children and young people. Thanks to the workshops and assemblies held over two years, there was talk about the feasibility of creating a project that generated the resources to support the school.

It was members of the community who proposed to sell bread, and gradually, within the brainstorming and participatory workshops, this idea became the creation of the community bakery that will cover multiple aspects; not only financial, but also educational and community-screening. The great success is that Santa Catarina Lachatao is recognized in the region for the quality of its artisanal bread.

On its own initiative, the community created the Community Technical School of Santa Catarina Lachatao. The school has been functioning for 4 years. However, it has no way of sustaining itself as it does not produce any income. Those who teach the classes do so voluntarily and sometimes receive very minimal financial incentives from parents.

How were community members involved in planning the project?

The community identified that community bakery will be the means to fund the school as they have the knowledge and talent to make high quality bread. Their product already has a demand to cover in the region and generate income for the school. Community members also arranged the place to be remodeled and equipped as a bakery. The selection, dimensions and type of furnace, and equipment, were planned by the community, where safety aspects and primary needs were also taken into account for their proper functioning.

There is an eco-tourism project in the community which serves local and foreign visitors by providing lodging and activities such as hiking, visiting the abandoned mine and a community museum.

During the workshops it was felt that the bakery can provide bread for visitors to the ecotourism project but it would remain autonomous, as the revenue is intended to be destined exclusively for the educational project. List any community members or community groups that will oversee the continuation of the project after grant-funded activities conclude. These may or may not be Rotary members or clubs.

A training program will be implemented by an expert baker. It will be planned for a small group of bakers in the region as the operation of the bakery involves equipment that operates at high temperatures or are either at risk.

Likewise, in the case of foodstuffs, the procedures for preparation, rest, cooking and cooling must meet precise times to ensure the quality of the foodstuffs.

Additional training covering health and hygiene aspects during food preparation is essential.

What process was followed to determine needs?

The Rotary Club of Xquenda Oaxaca in conjunction with the community and the expert baker, determined the necessary training for the bakery workers to understand the processes and technical specifications of the equipment, and the preparation of bread. The training will serve three main areas: safety, quality and productivity, and health and hygiene.

What incentives (e.g. financial compensation, awards, certifications, or advertising) will be used to encourage community members to participate in the project?

Certifications will be given to training participants.

# Funding

Will any elements of the project generate revenue that will be used to finance the project in the long term? If so, explain.

The creation of the Santa Catarina Lachatao bakery of is a community project for job creation and income, with the participation of students and parents. The specific objective is of providing sustainability to the community and the training center of Santa Catarina Lachatao.

The bakery will be a bread supplier for the local tourism company, the community of Santa Catarina Lachatao, and neighboring communities.

By providing the project with professional equipment, the space dedicated to bread production, and expert training, the bakery will be positioned as the best of the Ixtlán district region, providing organic products throughout the year.

Offering a variety of baked bread daily with high standards of hygiene and quality at competitive costs will benefit consumers in the region.

## Goals:

- Provide economic solvency and social profitability.
- Provide sustainability to the primary and secondary biocultural school
  - Generate income and the participation of students, teachers and parents
  - Obtain profits of 40% per year that benefit the school of Santa Catarina Lachatao.
- Offer a wide variety of bread products year round.
- Generate employment for people in the community.

## Market aspects

In Oaxaca bread is a staple of the population. Between 80% and 90% of the population in Oaxaca, is a consumer of white bread and traditional bread daily. The intake of bread is 90 grams daily, 33 kg per year. So it's considered a great opportunity.

Vendor selection of vendors was made primarily by their reputations and, above all, by its social commitment. Vendors selected have also given us a preferential price because they sympathize with the project.

A direct contract will be carried out, as, in our location not all the equipment is obtainable. Furthermore, when quotes were requested via the Internet or via telephone to suppliers in Oaxaca de Juarez, not everyone responded. Another local supplier was consulted for a quote but their charges were much higher and they did not have all the equipment needed to carry out the project.

The equipment will be operated by the 3 bakers in the town. The maintenance of the equipment will be carried out by the supplier.

Both the project managers and the parent society will be responsible for requesting and/or performing maintenance and purchasing necessary supplies to make bread or to make repairs. In addition, suppliers provide maintenance service and provide spare parts for electrical equipment, which are also warranted for one year.

# Explain why.

The communities of the Sierra Norte de Oaxaca, including Santa Catarina Lachatao, are familiar with the craft of bread making. That is why the furnaces that were chosen for the project are grout furnaces, made of red brick. Additional equipment to facilitate the work and improve productivity are a blender and a kneader, tasks that were previously done by hand. Given the nature of the project and its projections, however, it is necessary to produce more bread and reduce production time.

Once the project is complete, to whom will the items purchased from the grant funds belong? No item may be owned by a Rotary member, club or district.

There is an internal agreement that supports the school and the working group. So the Community Academic Training Center of Santa Catarina Lachatao will own the bread company, the equipment acquired with grant funds, the profits that are generated and the equipment that is subsequently purchased for the school.
