### **Project planning**

### Describe the community needs that your project will address.

A problem exists in the management of the population's solid waste in the community. This is especially significant with the recycling of plastics, PET and HDPE, which currently generate more than 40 tons of waste, of which only 10% is recycled. The confinement of the waste is increasingly more challenging with the increase in population.

#### How did your project team identify these needs?

The Rotary Club of the Mixtec has several years working with recyclers, seeking to improve the local conditions. Initially they dealt with the health and hygiene aspects and now they are looking to generate an economic resource from and for the local population.

## How were members of the benefiting community involved in finding solutions?

After being made aware of the possibility of receiving environmental and economic value from the recycled products community members formally organized to contribute to the design process by aligning with students from the technological university of the Mixtec.

### How were community members involved in planning the project?

They participated in design and with the contribution of ideas and experience, when attending project planning meetings.

In parallel with the club's work in the community, the ENACTUS-UTM organization works to improve recyclers' living conditions, training them in aspects of waste management, hygiene, safety work and other related topics..

For the management of machinery and the recycling process, training is planned from the installation of machinery until commissioning, as well as in troubleshooting any problems in installation and functioning. While they know the recycling process well, efficient management methods will be strengthened.

#### How were these needs identified?

Processes were analyzed and broken down into specific labor requirements per project design, from training for machine handling to product handling and efficient storage methodologies.

Proportional distribution of profits will be managed based on the work done relative to earnings, so that those who work the most in the project with the most resources will be incentivized.

In the community there are no companies that manufacture such machinery, so we outsourced the search relative to price and guarantee of machinery and installation.

The training will be provided by the supplier when initially installed, and the supplier gives a year's warranty of the equipment against defects in manufacturing. With the sale of the PET, HDPE will generate revenue that will allow the maintenance of the project and plans to expand its capability.

A percentage will be used for machinery maintenance, another percentage for a social benefit fund, another part to create a fund for project growth and expand goals.

After these funds the profits distributed in proportion to the work of each of the Recyclers.
