Project Overview

Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

Grant request seeks to:

- * Enhance Student Teacher skills in remote teaching to COVID -19 impacted indigent (extremely poor) children in Tijuana
- * Assist Student Teachers with appropriate skills and hours which meet their graduation practicum requirement
- * Assist Student Teachers with virtual teaching methodology
- * Improve teacher outreach to indigent children in remote areas who are impacted by both travel challenges and social distancing imposed by COVID-19
- * Enable the recipient population (indigent students) in the methodology of remote learning

Background (pre-COVID history):

The program has been ongoing continuously for 23 years, provides quality teaching opportunities for the UABC Student Teacher curriculum and quality educational content to indigent students as referenced above. Student teachers from UABC fulfill their practicum of 200+ hours via an agreement with this program.

There is an MOU between TJRC and UABC so that Student Teachers provide the tutoring and classes as part of their practicum. TJRC had provided the brick and mortar space for the in-classroom delivery educational content by the teachers, as well as economic assistance to the indigent children who would otherwise be unable to attend classes due to the cost. The program has been so successful that the Tijuana Rotary Club and the Tijuana Municipality have co-ventured in the recent construction of a Community Center to handle the increased student load.

Enter COVID-19:

The pandemic has provided significant challenges to both student teachers and students to continue in an in-classroom environment. It has also, however, provided a great opportunity to expand the program geographically via virtual teaching/learning. A significant side benefit of remote teaching is that the recipient student population can now be markedly expanded via the increased outreach afforded by remote learning processes.

The COVID-19 pandemic has necessitated social distancing, and a paradigm shift to a remote teaching/learning model. Therefore, remote teacher training and student remote learning is needed. All student teachers and students in the program have received a guided technical survey and where needed outfitted with primitive mix of dated hardware.

Project planning

Describe the community needs that your project will address.

Innate to this project has been an annual needs assessment by the Tijuana Rotary, along with volunteer teachers from La Jolla, California (USA) and the local Tijuana community via Student Teachers from UABC. The pre-existing project was a brick and mortar program assisting the UABC Student Teachers in completing their required practicum for graduation. The COVID-19 pandemic has threatened the survival of the Laboratory and the ongoing training of the UABC Student Teachers in this pre-existing form and function. To both alleviate the situation and enable the future growth of the project beyond what has been possible under the present delivery system:

The acquisition of remote teaching skills by the UABC Student Teachers will initially supplant the older brick and mortar methodology and, post COVID, will work synergistically with it to augment future in-classroom and hybrid virtual experiences for the Student Teachers and students. Therefore the remote teaching capability is the key aspect of the grant.

1. COVID-19 has changed the training environment, requiring a remote teaching methodology to augment the in-classroom experience. The remote teaching element included as a key aspect of the grant will facilitate continued training.
2. In addition, lack of appropriate remote learning technology along with progressive obsolescence of the computer technology currently in place must be updated to overcome this inadequacy.

How did your project team identify these needs?

Working with our partners and the leadership of UABC we have identified additional training opportunities for the Student Teachers with regard to remote teaching methodologies, video conference technology and student engagement techniques. These additional training opportunities will be fulfilled with our partner Tu+Yo.

How were members of the benefiting community involved in finding solutions?

The program evolved from a Rotarian driven teaching model to a collaboration with UABC, recognizing the need for benefiting Student Teachers experience. Thereafter, Student Teachers were brought in to gain valuable teaching experience and credit, as well as provide additional expertise and input in the development of the school's curriculum.

Due to the COVID-19 pandemic remote training and learning became essential to fulfill the needs of the Student Teachers in this program by supplying them as well as the indigent children with appropriate technology and methodologies to facilitate remote learning. The methodologies shall be guided with the expertise of Tu+ Yo Foundation.

How were community members involved in planning the project?

Members of the Tijuana Rotary Club work with the leadership of UABC to assure a quality Student Teacher experience in order to benefit our overall program. Tijuana Rotary Club also collaborates with the Club La Jolla volunteers to design an effective curriculum for the student teachers. The addition of another key community contributor is Tu+Yo Foundation. Through our ongoing communication it has led to the future integration, implementation and execution of their remote teaching methodology. As a valued member of the greater Tijuana community, Tu+ Yo Foundation will be integral to the ongoing success of this program and its future potential.

At this point in time there is no known remote teaching methodology in place for training and enabling Student Teachers in the Tijuana community. This project will both enable the Student Teachers in fulfilling their teaching requirement and enhance their remote teaching skills. It will also provide the learners (i.e. indigent children) in the Tijuana community the ability to continue their education in a COVID-19 impacted environment and beyond. Both sides of this issue (remote teaching and remote learning) must be enabled simultaneously through the grant to carry on the needs of the UABC student teachers.

Please describe the training, community outreach, or educational programs this project will include.

Tu+Yo partners with a new organization AVANT which specializes in virtual training methodology. The attached document explaining the eight step process will be used to support the Student Teachers.

How were these needs identified?

The existing program entailing a Rotarian driven teaching model in collaboration with UABC, was placed at great risk with the onslaught of the COVID-19 pandemic. The result was to establish a remote teaching and learning methodology. Student Teachers were brought in to gain valuable teaching experience and credit, as well as provide additional expertise and input in the development of the school's curriculum. Within the past many months it became obvious that antiquated technology and new teaching methodologies must be implemented to assure long term success.

What incentives (for example, monetary compensation, awards, certification, or publicity), will you use, if any, to encourage community members to participate in the project?

The incentive is built into the Enablement of the Students Teacher Graduation from UABC which is the goal achieved through completion of the required teaching practicum. The incentive for the indigent children is the continuation and completion this historically sucessful program, designed to support their graduation from secondary school, through the incorporation of this remote teaching method. All human resources related to the grant needs have been, and will continue to be, provided on a voluntary basis by Rotarians.

Asset Tracking & Remote Training Methodology:

- * Tu+Yo will provide access to Google University and Google Meet as the single point of educational engagement. This platform will be reviewed by the CTO on a regular basis while the La Jolla and UABC teachers update the lesson plans and assignments.
- * Chromebooks and other hardware will require periodic assessment (remotely) to assure functionality of the software and applications. This assessment will be done in two parts-
 - 1: technical needs by our CTO via productivity software and
 - 2: asset confirmation of inventory by our partner Tu+Yo.

Chromebooks:

The Chromebooks are used by the Student Teachers and the indigent children to access their resources for the classes. These are maintained and managed by our Tech team (CTO). The in-house tech team check and install updates and software as required in order to have the devices in optimal condition along with antivirus to maintain optimal performance.

Describe how community members will maintain the equipment after grant-funded activities conclude. Will replacement parts be available?

- * Our association with Tu+Yo Foundation will facilitate the equipment dispersal and inventory, its use and any future need.
- * Volunteer Chief Technology Officer (CTO) will assure optimal performance of all hardware.

The technology is ubiquitous and virtually the same with the exception of the native language used in the

programs and the User Interface. We see these computers and equipment as an easy natural transitional fit. The Chromebook hardware is generic and used worldwide.

No proprietary software has been required to carry out the curriculum and training. The issue of cultural appropriateness is inapplicable to this project with regard to technology.
