## Project Overview

---

**Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?**

This water project is to improve the hygiene and sanitation status of about 1800 household and an estimated 7500 people in the Kagugu parish ( a semi arid Lee Ward) of Ntungamo District.

Main objectives include, 1. establishment of 5 boreholes and 4 shallow wells in these villages; and 2. train community in hygiene and sanitation as well as management and maintenance of the wells for longer sustainability after the global grant is gone.

The origin of partnering with Habilitation and rehabilitation agency in this project is that the agency has been working in the same area for the last 5 years meaning it will help in mobilization, sensitization and more importantly become a strong stakeholder during sustainability and of whose beneficiaries are still the beneficiaries of this project in the area.

Being in a semi arid area, many Kagugu natives shall be the main beneficiaries for they have been suffering for so long in lack of safe and clean water due to inadequate and non functioning water sources . Documents and pictures of non functioning and non safe shallow wells are attached.

#### Project planning

#### Describe the community needs that your project will address.

Kagugu Prish as a whole is affected mostly by lack of safe clean water especially for domestic use, for example HARA has been receiving many complaints from clients of diseases related to poor unclean water used in their homes.

This project will focus on improving availability of clean and safe water near homes in the community. It will contribute to better hygiene and sanitation status of 1800 households of about 7500 people who currently have to walk about 10 miles to fill their plastic jerrycans with muddy water from holes also used by animals. Completion of the project will indirectly lower occurrence of poor water related diseases such as typhoid, diarrhea, and other skin diseases. The project will also indirectly enhance environmental protection by encouraging benefiting community to plant trees around water sources.

**How did your project team identify these needs?**

After many complaints from the parish natives, HARA analysis on why water borne diseases such as flu, cough, and diarrhea are common in their project clients and after requests from the church of Uganda to the Rotary club of Ntungamo to help them build water sources, as a club, a needs assessment was carried out and found that water is the most pressing challenge in this area!

Series of communication, pictures of sessions with community and related institutions were exchanged between international and host club as they carried out community survey of needs. Community assessment was carried out by the rotary club of Ntungamo, the host club for this project in association with the local NGO- Habilitation and Rehabilitation Agency (HARA). As direct beneficiaries and major stakeholders, Villagers, village leaders, and institutions such as schools, churches, and communities were involved in determining the needs for clean and safe water.

**How were members of the benefiting community involved in finding solutions?**

Through consultations in meetings and interviews, decisions regarding this need had to be discussed and the community was committed to contribute to the project in terms of providing land where the bore holes will be sighted, maintenance of and security for the boreholes where necessary.

**How were community members involved in planning the project?**

Community members were actively involved in setting up potential implementation steps especially plans to monitor and ensure operations and maintenance of water sources by setting up village savings funds for maintaining operations; Setting up community water user committees that when trained will monitor and evaluate performance.

1. project management education for village water user committee to help with monitoring and evaluation of water sources
2. Bookkeeping and accounting procedures for committee overseeing village savings funds
3. Train organized community groups on savings and credit association methodology

**How were these needs identified?**

Needs were identified through series of assessment meetings and discussions with community groups who in addition to the most critical and basic need of clean and safe water requested training in monitoring, keeping accounting records, managing, maintaining, and sustaining the water sources.

As much as the community members and key stakeholders have already committed resources including land and time in the project, incentives such as;

1. Certificates or award of completion to trained individuals could be used to encourage continuing participation and enthusiasm in the the project.
2. At launching, the project will be handed over to the community members to give them more authority to supervise & care for the water sources.
