



### **Vision 23-24: District Achievement Awards**

Rotary's Vision: "Together we see a world where people unite and take action to make lasting change.... across the globe, in our communities and in ourselves."

Clubs may qualify to be recognized for notable achievement, based on the number of total points attained during the 2023-24 Rotary year. Clubs must achieve ALL mandatory requirements in each category to qualify for Platinum or Gold medalist. Clubs must complete AT LEAST 7 mandatory goals to qualify for Silver and Bronze medalist. The achievement categories are as follows:

Platinum Medal: 500 or more points Gold Medal: 420 to 499 points Silver Medal: 340 to 419 points Bronze Medal: 250 to 339 points

Contact your area governor if you have questions or need assistance.

Rotary Presidential Citation 2023-2024: Rotary can automatically verify many of your club's achievements by keeping your club and member information up to date in Rotary Club Central. To be eligible for the Rotary Citation, clubs need to begin the year as active clubs that are in good standing and remain so throughout the year. Go to <a href="www.Rotary.org">www.Rotary.org</a> - My Rotary - Rotary Club Central to see Rotary Presidential Citation guidelines for specific details on how to qualify for recognition.

### **Membership:**

- **Mandatory 10 Points:** Club Membership Chair or Membership committee member attend 2023 Membership Summit on August 24, 2023 (or if rescheduled, whenever scheduled).
- **Mandatory 5 Points**: Appoint an active club membership committee of 3-5 members and enter the chair in Rotary Club Central by May 15, 2023.
- Mandatory 5 Points: Enter Membership goals in Rotary Club Central by May 15, 2023.
- **15 Points:** Increase club membership by 15% by April 1, 2024 (Membership increase is based on active membership on April 1, 2023.
- 20 Points: Sponsor/co-sponsor a new club or new satellite club by April 1, 2024.
- 10 Points: Conduct 2 new member orientation programs (extra 5 points with an AG present at 1 orientation).
- 10 Points: Submit Membership Action Plan (MAP) by September 30, 2023.
- **5 Points:** Club improves member retention rate by 1 percentage point or achieves/maintains membership retention of 90% or higher.
- **5 Points**: To encourage diversity, club achieves a net 1 gain in one of the following categories: female members, members under the age of 40, members of any minority population.
- **5 Points**: Club holds *Discover Rotary* program at least 1 time (separately or partnering with another club) to introduce new prospects to Rotary.
- **5 Points:** Engage all new members' participation on a specific committee, subcommittee, club project or leadership role within 6 months of induction.

- 10 Points: Arrange a program on Polio Plus by April 1, 2024.
- **5 Points:** At least 2 club members attend Grants Management Training on January 28, 2023 with emphasis on the member of the club who writes and submits the grants.
- 10 Points: For each new Paul Harris Society members by April 1, 2024, up to 20 points.
- 10 Points: For each new Bequest Society member by April 1, 2024, up to 20 points.
- 10 Points: For each new Major Donor by April 1, 2024.
- 5 Points: Club achieves 100% Sustaining status for 2023-24.
- 5 Points: Club nominates a Rotary Peace Fellow candidate in 2023.

- 2 Points: Appoint a Foundation committee comprised of no less than three members.

- Mandatory (5 Points): Appoint the Youth Service Chair to report plans and goals at the DG official club visit and report Club Youth Service Chair in DACdb by May 15, 2023.
- 20 Points: Recruit family to host an Inbound Exchange student for 2023-24 or 2024-25.
- 15 Points: Sponsor a Four-Way-Test speaker at the annual district competition on February 24, 2024.
- 10 Points: Sponsor an Interact Club (5 points if you co-sponsor). Up to 20 points max.
- **20 Points:** Sponsor two Outbound Youth Exchange Students candidate who applies by deadline. OR **10 Points:** Sponsor one Outbound Youth Exchange Student candidate who applies by deadline.
- 15 Points: Sponsor two students for RYLA in summer of 2024.
   OR 10 Points: Sponsor one student for RYLA in summer of 2024.
- 5 Points: Utilize Interact Clubs in Community Service Projects.
- 5 Points: Mentor/tutor students in a school or after school program.
- 5 Points: Interact club is recognized with the Rotary Citation for Interact Club.

### **How to Earn a Rotary Citation**

Your Rotary, Rotaract, or Interact club can earn a Rotary Citation for achieving goals that strengthen Rotary and your club. Goals include increasing club membership, developing sustainable service projects, giving to The Rotary Foundation, and building awareness of Rotary in your community.

### **Citation for Rotary Clubs**

Citation goals can be found in Rotary Club Central. To achieve the Rotary Citation, review the 25 available goals, select at least 13, achieve those goals, then report your achievement in Rotary Club Central.

All activities need to be completed by 30 June.

### **Citation for Rotaract Clubs**

Rotaract clubs that achieve the Rotaract goals by the end of the Rotary year will earn a citation.

Only Rotaract clubs that are listed as active in Rotary International's database can earn the citation. To confirm that a club is active, Rotarians can check the Listing of Club-Sponsored Organizations in Rotary Club Central.

All activities need to be completed by 15 August.

The Rotaract club president or Rotary sponsor club president can nominate a Rotaract club by completing the online nomination form for the citation by 15 August. Only one nomination should be submitted for any given Rotaract club.

#### Citation for Interact Clubs

Interact clubs that achieve the Interact goals by the end of the Rotary year will earn a citation.

Only Interact clubs that are listed as active in Rotary International's database can earn the citation. To confirm that a club is active, Rotarians can check the Listing of Club-Sponsored Organizations in Rotary Club Central.

All activities need to be completed by 15 August.

The sponsor Rotary club's president completes the online nomination form for the citation by 15 August. For Interact clubs with more than one sponsor club, only one nomination should be submitted for any given Interact club.

### CLUB PRESIDENT'S CALENDAR ROTARY YEAR 2023-2024

Success leading your Rotary club is determined long before you are sworn in as President. The most difficult part of the process is the six months before installation. Begin the planning process now, and you will be better prepared to implement the activities and assignments during that period without being overwhelmed. This is a general outline you can tailor to the practices of your Club and your own goals and objectives.

### January 2023 (6 months): Vocational Service Month

- Meet with your Area Governor, President, Foundation and Membership Chairs to review the mid-year progress towards the club's goals and objectives. Check club progress on achieving the Vision 2023: District Achievement Award and Presidential Citation.
- Review with your President the club's current budget.
- Work on your draft calendar and Club Goals for your year.
- Make sure you know how to access and use the District Database and RI's Rotary Club Central (My Rotary). Use your AG as a resource if you need help navigating either of these.
- Register (DACdb) & Attend Grants Management Training January 28<sup>th</sup> at Randolph Community College. President Elect or Foundation committee member and at least one other club member (preferably one who will be managing club grants) MUST attend this session for club to be qualified for District & Global Grant participation in 2023-2024.
- Register for PETS, March 16-18 at Sheraton/Koury Convention Center. (Must attend PETS and should bring President Nominee as well) Notify DGE Van Lankford if you are unable to attend Carolina's PETS & then make arrangements to attend an out-of-district PETS session.

### February 2023 (5 months): Peace and Conflict Prevention/Resolution Month

- If you have not already, Register for PETS, March 16-18 at Sheraton/Koury Convention Center (Must attend PETS and should bring President Nominee as well). Notify DGE Van Lankford if you are unable to attend Carolinas' PETS & then make arrangements to attend an out-of-district PETS session.
- Register to attend District Conference 2023 to be held May 4-7 at Le Meridian, Charlotte, NC.

### March 2023 (4 months): Water and Sanitation Month

- Attend PETS, March 16-18 at Sheraton/Koury Convention Center, Greensboro.
- Meet with your new board to finalize committee assignments, budget, projects, and calendar.
- Submit Club Memorandum of Understanding (MOU) by March 31.
- Submit student participation form for RYLA by March 31.



# **MEMBERSHIP CLUB TYPES**

#### **Traditional Rotary Club**

Professionals and other leaders who meet regularly for service, connection and personal growth.

- Appeals to people who are looking for fellowship, leadership development, networking and service opportunities.
- 20 members are needed to charter a new Rotary club.

#### Satellite club

A section (subdivision) of a Rotary or Rotaract club that has its own meetings, projects, bylaws and board, run in collaboration with its sponsor club.

- Appeals to those who want a club experience or a meeting format or time other than what's offered by other clubs in the area but also appreciate the support and partnership of another (Traditional) club.
- Eight (8) members are needed to charter a satellite Rotary club.
- Examples: Evening Meeting Time, Retirement Community and Young Professionals.

#### **Cause-Based**

A club whose members are passionate about a particular cause and focus their service efforts in that area.

- Appeals to people who want to connect with others while addressing a particular set of problems.
- Generally, set up as a satellite club that needs a minimum of 8 members to charter.
- Examples: Environment, Law Enforcement, Social Justice and Veterans

# **Interest-Based**

A club that focuses on a particular interest or hobby.

- Appeals to people who want to enjoy Rotary in a specific way or focus on a shared interest or activity, such as professional development for members.
- Generally, set up as a satellite club that needs a minimum of 8 members to charter.
- Examples: Chess, Gardening, Golf and Tennis



#### ALTERNATIVE MEMBERSHIP MODELS

#### **Corporate Membership**

While a corporation or company cannot technically be a member of a Rotary club, Corporate Membership allows a corporation or company in the club's area to appoint designees as Active Members to attend meetings, serve on projects, vote on club matters, and serve as club officers and on club committees.

- Each corporate partner can have designees of which at least one typically must be a member of that organization's senior executive group.
- Designees are official members of the Rotary club who pay RI dues and receive a subscription to the relevant Rotary magazine.
- Clubs determine attendance requirements, club dues and club fees for corporate designees.

#### Family Membership

We don't have a specific definition for this membership type because it has been done in many ways under the *Innovative and Flexible Rotary Clubs pilot*. Family Membership functions like the Corporate Membership in the sense that you are allowing members to share club membership with more than one individual.

# **Satellite Membership**

Satellite Membership allows an individual to be a member of a Rotary club, participate in its activities and projects while meeting at an alternate time and location from the traditional club meeting time and location.

- Clubs determine any club fees or dues, attendance requirements, and support requirements for The Rotary Foundation.
- Satellite members are active members, pay RI & District dues, attend alternate meetings and service projects.

# Service Choice Membership

Service Choice Membership allows an individual to participate in service projects, attend meetings when possible, vote on club matters, and serve as club officers and on club committees.

- Service Choice members are official members of the Rotary club who pay RI dues, club dues and club fees and receive a subscription to the relevant Rotary magazine.
- Clubs determine attendance requirements.



# **Service Choice Membership Fact Sheet**

#### **Service Choice Membership**

Service Choice is a membership type that allows Rotarians to pay a reduced rate for normal club dues and pay as you go for meals, socials, and other functions attended.

#### Rationale

Many potential members would like to participate in club service projects, socials, and other activities but cannot attend traditional club meetings for various reasons. Consequently, under traditional club pricing models, club members are paying for meals they do not consume. The Service Choice approach allows Rotarians to be full-fledged members and pay separately for any regular meetings or social activities they attend.

#### **Pricing**

In District 7690, the cost of required Rotary International and District dues is approximately \$150.00 annually. Pricing for Service Choice membership ranges in our District from \$175.00 to \$300.00 annually. Some clubs choose to collect Paul Harris Sustaining membership which is included in the above cost. Most clubs include some additional funding for administrative costs such as badges, pins, etc. Some clubs bill members quarterly and some annually.

#### **Considerations**

Service Choice memberships account for about 15% of new members across District 7690. This percentage has been steadily rising. Also, this membership type has allowed clubs to retain some members who had planned to leave a Rotary Club.

Like other membership types it is imperative to get new members onboarded properly and keep them engaged.

# Rotaract - Community or University Based Join the movement!

**Why?** Want to grow as a leader, advance your career and professional skills - to make a real difference in your community and in the world? Join the global movement of young leaders who are developing innovative solutions to the world's most pressing challenges.

**Who?** Rotaract clubs bring together people ages 18 and older to exchange ideas with leaders in the community, develop leadership and professional skills, and have fun through service.

What's involved? Rotaract members decide how to organize and run their clubs, manage their own funds, and plan and carry out activities and service projects. Rotary club sponsors offer guidance and support and work with the club as partners in service. Rotaract organizers are encouraged to share their progress with Rotary sponsors and if necessary, seek assistance from their Rotary sponsor.

#### How to Start a Rotaract Club

Getting involved in Rotaract can be a fun, impactful, and transformational experience for more than just young leaders in your community — it will inspire and engage your Rotary club members, too!

- 1. Familiarize yourself on all things Rotaract. A great place to start is by reading the Rotaract Handbook. Deepen your knowledge with the Policy Related to Rotaract.
- 2. Gather a team. Bring together a group of Rotarians and community members committed to supporting your new Rotaract club.
- 3. Know your audience. Assess the makeup of your community and determine if you will start a university or community-based Rotaract club. Rotary's Engaging Younger Professionals Toolkit helps clubs understand this demographic, create a vibrant club culture, and communicate Rotary's value.
- 4. Strategize to attract your audience. Determine a target audience and identify the locations and opportunities to promote the formation of a new Rotaract club. Schedule a kickoff event that will appeal most to your target audience to introduce potential members to Rotaract, such as a happy hour, service project, info session, or your own creative invention.
- 5. Create and share promotional materials. Solidify your value proposition and clearly articulate benefits of joining your Rotaract club in promotional materials. Use Rotary's Brand Center to create digital and print resources and share Rotaract videos on social media.
- 6. Host your kickoff event. Engage all attendees and talk to them about why they came and how they are interested in changing their community or growing as a leader—make sure to get their contact information.
- 7. Follow up with attendees. Personally invite them to the first Rotaract club meeting.
- 8. Support the first few months of Rotaract club meetings. Your team should assist in the early stages of the Rotaract club by helping set up the club administration. Advise on adopting the Standard Rotaract Club Constitution and Recommended Bylaws, organizing officer elections, selecting meeting locations, and arranging an initial service project.
- 9. Certify the club. Submit the Rotaract certification form along with the one-time US\$50 certification fee to Rotary International to officially recognize that your Rotary club will be sponsoring a new Rotaract club.
- 10. Stay connected. Plan to regularly attend the Rotaract club's meetings and events and invite the Rotaract club to collaborate with your Rotary club in your activities and events. Share the success of your Rotaract club with Rotary International at <a href="mailto:rotary.org">rotary.org</a>. Submit annual Rotaract Club Contact form.

#### RI FOUNDATION CLUB RECOGNITIONS

#### 100% Foundation Giving

This banner is awarded to clubs that achieve an average of US \$100 and 100 percent participation with every active (dues paying) member contributing some amount to any/all designations including the Annual Fund, PolioPlus Fund, approved global grant, and the Endowment Fund during the Rotary year. This annual banner recognition is awarded at the conclusion of the Rotary year.

#### 100% EREY Club

For clubs that achieve a minimum Annual Fund contribution of \$100 per capita during the Rotary year, and every dues-paying member must personally contribute at least \$25 to the Annual Fund during the year, this annual banner recognition is awarded at the conclusion of the Rotary year.

#### 100% Paul Harris Fellow Club

To be eligible, every active (dues-paying) member of the club must be a Paul Harris Fellow at the time banner recognition is requested by your District Governor. This banner recognition is only awarded one time to a Rotary club, but the intent is that the club will keep its membership at 100% Paul Harris Fellows in future Rotary years.

A club representative must contact the district governor after determining that all current, dues-paying club members are Paul Harris Fellows. The District Governor must confirm that all members are Paul Harris Fellows by using the Club Recognition Summary and notify The Rotary Foundation by emailing RotarySupportCenter@Rotary.org

#### 100% Paul Harris Society Club

To be awarded to clubs in which every active (dues-paying) member has contributed a minimum of US \$1,000 outright to the Annual Fund, End Polio Now Fund and/or an approved global grant during a given Rotary year. This annual banner recognition is awarded at the conclusion of the Rotary year.



#### POLICY FOR GRANT FUNDING 2023-2024

#### Club Eligibility to Apply for District and Global Grant Funds

- All clubs must be qualified to apply for District or Global grant funds (Attend Grants Management Training and properly submit MOU by April 30, 2023).
- All clubs must submit complete project final reports within one month of project completion maintaining established stewardship practices. The latest a final report may be submitted is May 15<sup>th</sup>.
- All clubs must submit complete district grant applications through the DACdb Grant module by established due date of May 31st.
- All clubs must match a cash contribution to the proposed project, equal to or greater than the allocation amount received from district funds.
- Clubs must be current in RI and district dues to receive these grant funds.

#### District Grant Funds Available for Qualified Clubs

Based on availability of funds, each qualified Rotary Club will be eligible to apply for and receive 20% of the amount the club contributed to the Annual Programs Fund three years prior. All clubs will be eligible to receive a minimum of \$400 from the District Grant Funds in the 2023-2024 year. Satellite Clubs are included in the Sponsor Club allocation and do not receive separate funding. See District Grants Allocation chart (in this manual).

After District Grant applications are recorded in the DACdb Grant module, the District Grant Committee will review all submissions and recommend funding to the District Governor (DG) and the District Rotary Foundation Chair (DRFC) for final approval and submission to The Rotary Foundation as a District Block Grant for District Designated Funds (DDF).

#### Global Grant Funds Available for Qualified Clubs

Global Grant funds are budgeted to allocate funds for Qualified Clubs to apply for Global Grants, Global Scholars and Vocational Training Teams. To assist the District Foundation Committee in Grant budgeting, clubs anticipating submitting a Global Grant application during the 2023-2024 Rotary Year must submit a written proposal to the Global Grants Chair on either the district's form or, if a facsimile, to include the host country, the area of focus, a description of the project, evidence of local community needs assessment, a balanced budget, including the amount of DDF requested, and if applicable, VTT and Global Scholars proposals may require additional information for the Global Grants Committee.

The Global Grants Committee is composed of the Grants Committee Chair, the DG, DRFC, DGE, DGN, and the Global Grants Sub Committee Chair. The committee will review all Global Grant project proposals and if they choose to, may include others in the review process. If approval is recommended by committee, clubs must complete Rotary International's Global Grant Application online.





#### POLICY FOR GRANT FUNDING 2022-2023 (continued)

#### Foundation Giving

Clubs are urged to consider the direct connection between clubs' contributions each year to The Rotary Foundation Annual Fund (SHARE) and the resulting amount of funds (DDF) returned to the district to be applied at the district's discretion to District and Global Grants.

#### **DISTRICT GRANT KEY DATES**

#### Grants for Current Rotary year- 2022-2023

- May 15, 2023 Last of Final Reports due from *current* Rotary year (District Grants 2022-2023) into DACdb Grants module. All final reports are due one month after completion.
- May 15 -May 31, 2023 –District Grants Co-Chair for Closing Grants (Karen Morris) to reconcile final reports of grants from *current* Rotary year, and Sub Committee Grants Chair (Pam Ray) will provide second signature for approval.
  - o District Leadership strongly encourages clubs to submit their final reports on their grants within 30 days of completion of the grant.
- May 31 June 15, 2023–District Grants Co-Chair for Closing Grants to summarize all *current* Rotary year final reports and submit to Grants Sub Committee Chair and DRFC to close the District Block Grant in RI Grants site.

#### Grants for Upcoming Rotary 2023-2024

- January 28th, 2023 Attend Grants Management Training to qualify your Rotary Club.
- Feb 19 Clubs begin to develop and draft applications for grants for *upcoming* Rotary year\_in DACdb Last date grant applications are accepted is May 31st, 2023.
- April 30, 2023 2023-2024 Memorandum of Understanding (MOU) signed by Club President and Club President-elect. Submit the MOU to Grants Sub Committee Chair Pam Ray.
- As Club Grants are submitted District Grant Co-Chair for Applications (Mary Joan Pugh), begins to review applications for *upcoming* Rotary year, and Grants Sub Committee Chair (Pam Ray) approves.
- May 31 June 30 2023– District Grants Co-Chair for Applications to compile all district grant applications for *upcoming* Rotary year into a District Block Grant to be submitted to The Rotary Foundation by the DRFC and DG, on July 1.

Projects may start when the District Block Grant has been approved by RI and the District Rotary Foundation Chair has notified the Club President in writing that the project may begin. NOTE: Final Reports for 2022-2023 District Grants are due one month after grant completion and no later than May 15, 2023.





#### TRIPLE CROWN CLUB



Clubs who achieve the status, will be recognized with a Triple Crown Badge on their club banners that will be displayed at District Conference as well as receive a badge that can be used on a club's own banner. Triple Crown status must be achieved on an annual basis to maintain the status.

The measuring period is from July 1 to April 1 of every Rotary year.

#### CRITERIA FOR ANNUAL RECOGNITION

- 100% Paul Harris Fellows-100% of a club's members must be recognized by Rotary International as Paul Harris Fellows.
- 100% Paul Harris Sustaining-100% of a club's members must be recognized as a Sustaining Member meaning that the member contributed a minimum of \$100 to the Annual Fund of the Rotary Foundation during the measuring period. (James Gouty) 8.8.23
- 100% Per Capita Polio Plus Contribution-A club must achieve a \$100 per capita contribution from its total membership.

A club's total membership for the purpose of measuring achievement will be based on the number of Rotarians who are members of the club between July 1-April 1 of the Rotary Year (excluding Rule of 85 and members on leaves of absence). Members who are inducted during the Rotary year or who leave during the measuring period are not counted towards the membership percentages.

#### Reporting PolioPlus Promise contributions to the District

We are keeping a record of who's signed the pledge to contribute \$100 each year. Please be sure to send either your PDF from your club's contribution form or have the member send us their email confirmation of their online donation. We do not need records of Polio contributions unrelated to the PolioPlus Promise campaign.

#### **Club Contributions Reporting**

To enter your club's contributions you go into DACdb. It's just like when you submit your member's annual fund PHF contributions, but you select PolioPlus on the form.

In DACdb go to My Club – Reports – and select the 2.1 Rotary Foundation Transmittal (TRF) report.

On the next screen that pops up click on View icon at the top of the screen.

If these are contributions by individual members you will want to enter each amount by member.

Screen shot example below shows how to enter each member's individual contribution or at the bottom if monies from a club fundraiser or event.

Then at the bottom of the form select PolioPlus as your Contribution Designation.

Click the yellow button that says Process and Print Page and this will generate a PDF for you to print (and save for your records). On the PDF you will note there is an option to enter your credit card information, or you can mail a check along with the form to the address provided.



# District 7690 Peace Building Resource Guide 2023-2024

**Peace building is the essence of the work of Rotary**. It is the core of Rotary's mission to "provide service to others, promote integrity, and advance *world understanding, goodwill, and peace* through our fellowship of business, professional, and community leaders." Looking at Rotary's seven areas of focus through the lens of peace, we see that successful service projects in any of these areas can promote peace by addressing the underlying causes of conflict, violence, and fear of violence. District 7690 takes action to support peace building in these ways:

#### **Peace Centers**

We are a <u>Peace Builder District</u>. Our District provides financial support that sustains the seven Peace Centers around the world, and we have a special connection to the only center in the Western Hemisphere — a combined program at Duke/UNC-CH. Rotarians in our District are encouraged to attend the center's annual conference in April to hear presentations of graduating scholars. Local scholars are invited to provide informational programs to clubs. Our clubs can assist them when they arrive in our country and host them in the District during their academic breaks.

#### **Peace Fellows**

Clubs look within their communities to identify and sponsor potential candidates for the 130 fully funded <a href="Peace Fellowships">Peace Fellowships</a> to study in Master's degree or certificate programs for careers in peace and development. Club programs educate members about the <a href="Role of Rotarians">Role of Rotarians</a> in recruiting and supporting Fellows. Key dates are recruitment of candidates from February through May 15, with applications due to RI on May 15 and final selections made in November for study beginning the following academic year.

#### **Global Grant Scholarship**

Clubs have another opportunity to recruit applicants for a District-funded <u>Global Grant Scholarship</u> in the amount of \$30,000 to pursue international graduate-level coursework or research. Study may be in any of Rotary's areas of focus, with the goal of a long-term commitment to working in the chosen area. Details are posted on the <u>District website</u>.

#### **Peacebuilder Clubs**

Rotary service at the local level is enhanced when we look at it through the lens of peace building. Clubs can become part of the network of <u>Peacebuilder Clubs</u> and use the resources of <u>Rotarian Action Group For Peace</u> and the <u>Institute for Economics and Peace</u> to increase community engagement and the effectiveness of service projects. Details on applying for this status are found on the <u>RAGFP website</u>.

#### **Youth and Peace in Action**

Clubs can engage high school students in their Interact or other community youth organizations, by connecting them with <u>YPA</u>, the largest youth peacebuilding initiative in the United States and Caribbean Youth. To receive and share information about peacebuilding in the district and connect with other clubs on peacebuilding initiatives, contact Peace Committee Chair Lynn Thompson at lynn.thompson.rotary@gmail.com.

Interact is Rotary International's service club for young people ages 12 to 18. As one of the most significant and fastest growing programs of Rotary service, Interact has become a worldwide phenomenon. Interact clubs are sponsored by individual Rotary clubs. They are self-governing and self-supporting clubs. Rotarians provide support by attending club meetings, encouraging student governance of the meetings and activities. They invite Interactors to participate in other Rotary sponsored programs such as Youth Leadership Camps, Rotary 4-Way Test Speech Contest and Rotary meetings and socials.

Interact clubs are encouraged to complete at least one community service or school project and one international project annually. Through these efforts, Interactors develop a network of local and international friendships and learn the importance of developing leadership skills. They demonstrate personal integrity and respect for others, they learn the value of individual responsibility and hard work. They experience the rewards of international understanding.

Starting an Interact Club is easy and rewarding. Though the Interact Handbook provides detailed instructions, highlights include:

- Take Action in your Rotary Club
  - o Gather a Team of Rotarians committed to supporting an Interact Club. Select a Rotarian advisor to help guide the group.
  - Visit the middle school or high school; get permission from the school leadership team to proceed. Select a school faculty advisor.
- Recruit Members:
  - o Determine a target audience and identify the locations and opportunities to promote the new club.
  - o Host a kickoff event/informational meeting where you explain Rotary: how it started, its mission and goals; get contact information to see if there is enough interest to start a club.
- Hold an Organizational meeting where you will elect officers and directors, establish dues, determine meeting place and time, decide on first Service Project, etc.
- Certify the Club:
  - o Adopt Standard Rotaract Club Constitution & Bylaws.
  - Complete Organization List (min.15 students) with students' names and contact information. This
    list must be signed by sponsoring Rotary club president, school faculty advisor, and the district
    governor.
  - o Send the Organization List to RI World Headquarters.
- Hold a Chartering Ceremony to pin the charter members.
  - o Invite District Leaders, key school personnel, parents...
  - o Sponsoring Rotary Club buys Interact Club supplies and banner.

Once an Interact Club is chartered, the sponsoring Rotary Club Team continues to meet with the Interact group monthly to collaborate, guide, exchange ideas, make sure that Rotary policies are followed, and ensure that by 30 June each year, the school faculty advisor submits the Interact Club Contact Information form.

#### **District 7690 Crisis Management Guidelines**

Rotary is a 116-year-old organization with a strong, trusted brand. It is important we continue to protect our brand by minimizing risk. In the event of a crisis, we need to be able to respond effectively, keep involved parties and Rotary International informed, and use the media, if engaged, as a liaison to disseminate key messages. The organizations response to a crisis often has more impact on reputation than the event the precipitated the situation. I suggest copying these guidelines to your mobile phone.

Should you experience a crisis during your year as Club President, take the following actions in the order listed. This list will help you handle the situation in an organized way that will mitigate risk to Rotary's reputation and brand:

- 1. Give priority attention to the care of the injured. Not all crisis situations will have injured.
- 2. Secure needed assistance doctor, ambulance, fire, law enforcement.
- 3. Ensure the safety of persons and property.
- 4. Contact the Crisis Manager, Steven Taylor: 919-270-7257. In the event you are unable to reach the Crisis Manager and it is urgent that you speak with a District representative, Public Image Chair Kathy Torrey will be a backup contact and may be reached at 910-603-0743. Add these numbers to your contact list in your cell phone for future reference. The Crisis Manager will contact the District Governor, Van Lankford: 336-407-1579.
- 5. Gather the facts before you speak with the Crisis Manager and Youth Protection Officer if youth are involved. Your fact-based detailed report should include who, when, where, what happened, the current state of the crisis, and is media involved. Ensure the Crisis Manager is fully briefed before referring the media to her.
- 6. The official statement you should make to the public/media:

  "At this time, we are in the process of gathering the facts related to this matter and I am not in a position to answer questions. We appreciate your interest and concern, and once we complete our investigation, we will provide an appropriate statement."

(Example:	"Our designated spokespers	son with respect to this matter will be

- 7. Keep the following in mind:
  - a. Do not bury your head in the sand. Pretending the problem will not exist will not make it go away. Be prepare to react quickly.
  - b. Do not panic. Stay calm and clearly define what has occurred. Avoid blame games or debates. Spend your initial time focused on establishing the nature and extent of the crisis, who it will affect, and what you need to do to manage the situation.
  - c. Get your facts straight. It is important to be able to demonstrate command of the situation and not be confused, unclear or unaware of the facts.
  - d. In conjunction with the District help to manage the communication. There should be only one spokesperson with respect to any statements made about the crisis. If you are selected to be the point of contact, be prepared to communicate clearly, honestly, and as often as needed. Without clear communication, people will fill the void with rumors and speculation.
  - e. Be honest in everything you say and do.
  - f. Do not play favorites with media or others. At the appropriate time, communications should be made clearly and concisely to all stakeholders.

- 8. When the crisis manager receives your call, she will work with you to determine the severity of the crisis, contact Rotary International 847-424-5394 and add District Rotarians to the crisis team, as needed. A designated spokesperson will be named to handle future inquiries from Rotary International, the public, or media. At the conclusion of the crisis, a written report will be completed and approved by the District Governor for the District's records. Any recommended changes to the Crisis Management Plan will be reviewed for implementation.
