The District Strives to create and maintain a safe environment for all youth who participate in Rotary activities. To the best of their ability, Rotarians, Rotarians' spouses and partners, and other volunteers must safeguard the children and young people with whom they come in contact and protect them from physical, sexual and psychological abuse.





- What is it?-The Policy adopted by District 7690 to Protect Our Youth.
- Who is a Volunteer according to the Youth Protection Policy-Any adult involved with Rotary Youth Activities who interacts with youth whether supervised or unsupervised.
- Who is a Youth Program Participant-Anyone who participates in a Rotary Youth Program, regardless of age of majority.





What do I need to do?

If the volunteer will have direct supervised contact with a Rotary Youth Program Paticipant.

- Any Volunteer who has admitted to, been convicted of, or has otherwise been know to have engaged in an act of Sexual Assault, Sexual Harassment, or an act of Moral Turpitude may not participate.
- Ensure that the Volunteer is properly supervised.

If the volunteer will have direct unsupervised contact with a Roatry Youth Program Participant.

- Complete a volunteer application form.
- Undergo a criminal background check
- Not be included in any sex offender registry.
- Be interviewed preferably in person.
- Provide a list of personal references with contact information (it is recommended that references include no family members and no more than one Rotarian)





YOUTH PROTECTION MOU

All Presidents for this Rotary Year should have signed a Youth Protection Memorandum of Understanding (it would have been sent to your recently to E-sign)

All Presidents for next Rotary Year should sign a Youth Protection Memorandum of Understanding (it will be sent to you to E-Sign sometime after PETs)

Why should you sign the Memorandum of Understanding?

- 1. Because you will be out of compliance with District, Zone and International Policy
- 2. Because if we accept and acknowledge the MOU and follow the Policy then our clubs liability will be greatly eliminated or reduced.





PICTURE CONSENT FORM

Why do we need picture consent forms?

- When dealing with minors some parents who did not specifically bring their children to a Rotary function directly might not want their Child's name, image or likeness used. Why?
 - 1. They may hold concern that their child's name, image or likeness may hold some future or current value that might be diminished by your possession of it.
 - 2. They may have religious reasons.
 - 3. They may specifically have relocated to avoid some person or individual and it's use may allow that person to track down the Youth Program Participant and their family.
 - 4. They may just want to be difficult. (and they are allowed to be)





- 1. **Psychological or verbal abuse** The use of fear, humiliation, or verbal assaults to control the behavior of another. Examples include rejecting the person, preventing them from developing normal social relationships, and making derogatory statements about their race, religion, ability, intellect, tastes, or personal appearance.
- 2. **Physical abuse** Physical contact intended to cause pain, injury, or other physical suffering or harm.
- **3. Neglect** Failure to provide the food, shelter, or medical care that is necessary to well-being.
- 4. Sexual abuse Engaging in or arranging implicit or explicit sexual acts, whether they are performed alone or with another person of any age or gender, through force or coercion or with anyone who is unable to give consent. Any sexual activity between a legal adult and a minor, or with a program participant under their authority, regardless of consent, is prohibited. Sexual abuse can also include non-touching offenses, such as voyeuristic behavior, indecent exposure, stalking, electronic harassment, or showing a young person sexual or pornographic material.
- 5. Sexual harassment Sexual advances, requests for sexual favors, or verbal or physical conduct of a sexual nature that is unwanted or directed at someone unwilling or unable to provide consent. In some cases, sexual harassment precedes sexual abuse and is used by sexual predators to desensitize or groom their victims. Examples of sexual harassment include: Sexual epithets or jokes, written or spoken references to sexual conduct, gossip about one's sex life, and comments about a person's sexual activity, deficiencies, or prowess. Giving private or secret gifts, including those of a sexual nature. Verbal abuse of a sexual nature. Display of sexually suggestive objects or images. Sexual leering or whistling. Inappropriate physical contact, such as brushing against a person. Obscene language or gestures, and suggestive or insulting comments.
- 6. **Grooming** the process by which an offender gains a young person's trust, finds their vulnerabilities, exerts their authority or control over them, and eventually draws them into a secret, sexual relationship.
- 7. **Consent** informed, knowing and voluntary permission for something to happen, including sexual activity. Minors and young people participating in youth programs cannot freely consent to sexual activity





EIVING AN ALLEGATION REPORT

- 1. Listen attentively and stay calm. Acknowledge that it takes courage to report abuse or harassment.
- 2. Be encouraging, but remain neutral; do not express shock, horror, or disbelief.
- 3. Assure privacy but not confidentiality. Explain that you will have to tell someone about the abuse or harassment to make it stop and ensure that it does not happen to others.
- 4. Get the facts, but do not interrogate. Ask questions that establish facts: who, what, when, where, and how. Reassure the young person that they did the right thing in telling you. Avoid asking "why" questions, which may be interpreted as questioning the young person's motives, imply they are at fault or that you may not believe them. Remember that your responsibility is to report this information to the proper authorities.
- 5. Be nonjudgmental and reassure. Avoid criticizing anything that has happened or anyone who may be involved even the accused, as this could be someone they care about. It is especially important not to blame or criticize the young person. Emphasize that it was not their fault and that it was brave and mature to come to you.
- 6. Document the allegation. Take confidential case notes, including the date and time, as soon after the report as you can. Try to use the young person's exact words. Be patient and understanding, as young people who have experienced trauma may have a hard time recounting details of their experience; encourage them to report as much as they can or feel comfortable sharing, and try to prevent situations where they may have to retell their experience again.





ALLEGATION RESPONSE

What should you do if an allegation of abuse is reported?

- 1. Protect the young person by removing that young person or in the case of multiple young people all of the young people from the situation.
- 2. Report all allegations to the appropriate authorities. First to law enforcement, then district leaders. Myself and the then sitting District Governor are the appropriate District leaders.
- 3. Remove the accused person from contact with youth.
- 4. Avoid gossip and blame. It is not our clubs or districts responsibility to assign blame or investigate proposed misconduct. Nor is it our position to decide right or wrong doing.
- 5. Follow through. Keep the lines of communication open between the clubs and district so that Rotary International can be properly informed.
